VOLUNTARY ANNOUNCEMENT INCREASE IN SHAREHOLDING IN THE COMPANY BY CONTROLLING SHAREHOLDERS

This announcement is made by Boltek Holdings Limited (the “**Company**”) on a voluntary basis.

The board (the “**Board**”) of directors of the Company (the “**Director(s)**”) has been informed by Waywin Investment Holding Limited (“**Waywin Investment**”), a controlling shareholder of the Company (as defined in the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”)), that on 30 March 2023, Waywin Investment acquired 57,600,000 shares of the Company (the “**Share(s)**”) at a total consideration of HK\$5,000,000 (representing an average price of approximately HK\$0.087 per Share) through an off-market transaction (the “**Acquisition**”).

Waywin Investment is wholly-owned by Mr. Cheung Kwan Tar (“**Mr. Cheung**”), the chairman of the Board, the chief executive officer and an executive Director of the Company, and accordingly, Mr. Cheung is deemed to be interested in the Shares held by Waywin Investment. Immediately upon completion of the Acquisition, Waywin Investment and Mr. Cheung were together interested in 541,200,000 Shares, representing approximately 67.65% of the issued share capital of the Company. The Board is of the view that the increase in shareholding interest in the Company by Waywin Investment demonstrates its confidence in the prospects of the Company.

Based on the information available to the Company and to the best knowledge of the Directors, the Company has maintained sufficient public float in compliance with Rule 11.23(7) of the GEM Listing Rules following the Acquisition and up to the date of this announcement.
